



## National 12 Mid-Winter Championships 2023 – Notice of Race

## 5<sup>TH</sup> February 2023

Organised by the Royal Harwich Yacht Club (RHYC).

# Notice of Race

## 1. Rules

- 1.1 The event is governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 [DP] The Port of Ipswich and the Harwich Haven Authority Byelaws also apply.
- 1.3 RRS 77 Identification on Sails does not apply. [DP] Boats shall however display a sail number or other clearly visible marking on their main sail that is distinct from that of any other boat in the same class entered in the event and shall inform the race committee of that sail number or marking when signing on for racing.

## 2. Eligibility and Entry

- 2.1 The event is open to all boats that conform to the "National Twelve Class Rules".
- 2.2 All competitors should enter the event via the RHYC's website or office.
- 2.3 Entry fees are as follows:
  - 2.3.1 £10 per boat.
- 2.4 Handicaps will not be used for this event.
- 2.5 [DP] Competitors under the age of 16 years shall be accompanied by a parent, guardian or someone over 16 years of age acting *in loco parentis* while at the club. The responsible adult shall remain at or near the club and be available to take responsibility for the competitor at all times while the competitor is at the club (including while they are on the water).

## 3. Sailing Instructions

3.1 Sailing instructions will be available on the RHYC's website.

## 4. Schedule

4.1 Racing is scheduled to take as below:

Date	Class	Scheduled time of warning signal for first race	Number of races scheduled for the day

- 4.2 Races will be sailed back-to-back, with the warning signal for each subsequent race being made shortly after the last boat has finished the previous race.
- 4.3 Competitors should be aware that during the day, two races for RHYC's 'Suffolk Shiver Series' are also planned and will be racing on the river.

### 5. Venue

5.1 Racing will be on the River Orwell.

### 6. Courses

6.1 Courses will displayed on the RHYC Race Hut or Committee Boat.

### 7. Scoring

7.1 The series score for each entry in the event will be the total of her race scores excluding her worst score, if 3 or more races are sailed.

## 8. Privacy Statement

8.1 The personal information you provide to the organising authority will be used to facilitate your participation in this event. If you have agreed to be bound by the Racing Rules of Sailing and the other rules that govern the event (the rules), the legal basis for processing that personal information is contract. If you are not bound by the rules, the legal basis for processing that personal information is legitimate interest. Your personal information will be stored and used in accordance with the organising authority's privacy policy. When required by the rules, personal information may be shared with the RYA, your national authority and/or World Sailing. The results of the event and the outcome of any hearing or appeal may be published.

#### 9. Risk Statement

9.1 Rule 3 of the Racing Rules of Sailing states "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in this event each competitor agrees and acknowledges that:

- a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- d) Their boat is in good order, equipped to sail in the event and they are fit to participate.
- e) The provision of a race management team, support boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- f) The provision of support boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.
- g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event, and to attend any competitor briefing held for this event.

#### 10. Insurance

10.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of  $\pounds 2m$  per incident or the equivalent.

#### 11. Prizes

- 11.1 There will be Prizes for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place overall.
- 11.2 There will also be Prizes for 1st Non-T Foil N12, 1st U21 N12 (helm), 1st U21 N12 (crew).
- 11.3 The helm & crew placed 1<sup>st</sup> overall will receive the RHYC N12 Mid-Winters Trophy.
